DEPARTMENT UPDATE:

Do in part, to a recent update in our DDP reporting software we are making some changes in how we track data within the department for 2008. In the past, if we made contact with someone that didn't require an actual report, we would document the incident on our daily report. That report is hand written and filed away at the end of each shift. In order to retrieve data from those dailies, we would have to go thru each and every one of them to find the information that we needed.

For 2008, we have a *Field Report* that is generated with every contact for which we generate a report number. Those field reports are then entered into our DDP program by our Clerk each day. A two month trial run of this procedure has been very positive. Since a large part of being successful in our business relies on a good database of information, this simple change should help us considerably.

MONTHLY ACTIVITY:

On December 8th, Officer Mercer stopped a van for a traffic violation. In that van she discovered one of the female occupants of the vehicle had a warrant. She placed her under arrest and searched her incident to that arrest finding a significant amount of crack cocaine on her persons. After transporting her to the jail, Officer Mercer noticed the prisoner acting strangely and discovered that the prisoner had smuggled narcotics into the jail and was trying to hide them while using the restroom. Officer Mercer's attention to detail and abhorrent behavior resulted in stopping narcotics from finding there way into the jail. The female prisoner was charged with multiple felony drug charges.
